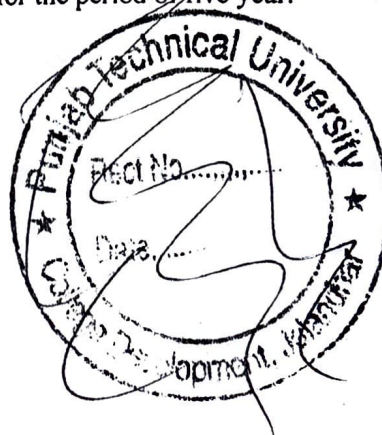
- ✓1. Appointment of qualified Principal and faculty as per UGC/PTU norms.

Inspections will be carried out after 20th may, 2013 by the University. I hope you might be able to comply to the above recommendations in the due course of time.

1. Change of Land Use Certificate (CLU).
2. Principal and Faculty to be appointed latest by 20th may, 2013.
3. Separate building and land has to be earmarked for running PTU non-AICTE courses.
4. (a) Endowment Fund of Rs. 10 Lakh (in the shape of joint FDR in the name of PTU and the Trust/College) for handing over to PTU in case of your proposal is approved.
(b) Working Capital: 10 Lakhs.
5. (a) Computer in ratio of 1:4.
(b) Peripherals in ratio 1:10 of number of computers.
(c) Books @ 500 per unit per year.
(d) Internet connectivity 2Mbps (leased / RF).
(e) Rooms ratio of 1:1 (i.e at least one room for one Unit).
(f) Legal software as per norms.
(g) Laboratory as per syllabus of 1st year.
6. Any other document as per UGC/PTU norms.
